At that time or anytime following, use of the camp can be issued to a different user without notice.

50% Payment is due 2 months in advance of the beginning date of use. Payment in full is due 12 days before the event. Payments past 30 days for any unpaid amounts are subject to a \$10.00 per month late charge and interest charges at 10% annual percentage rate.
